



## Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies currently recommend social distancing and have limiting the number of people congregating currently to 10 or less.

In our state of Illinois, Phase 3 adheres to people congregating to 10 or less. In Phase 4, groups of 50 or less will be allowed. It is only in this Phase 4 that our camps will occur.

The Studio, LLC, has put in place preventative measures to reduce the spread of COVID-19; however, The Studio cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending classes, camps, rehearsals or sessions at The Studio could increase your risk and your child(ren)'s risk of contracting COVID-19.

Below are the policies and procedures we have implemented to reduce the spread of COVID-19. We need you to acknowledge these policies prior to sending you child(ren) to attend activities at The Studio:

- We may need to require forehead temperature checks for all participants. We will do temperature checks on our instructors/directors prior to each event.
  - If you have a temperature of 100.4 or above, you will be asked to leave.
- If there is evidence of anyone arriving “under the weather,” we ask you not attend that day. Symptoms such as:
  - Coughing
  - Chills
  - Sore Throat
  - Difficulty Breathing
- ***You must register in advance for camp. If you are not registered, you CANNOT attend.***
- Each camper will be assigned to a team. Once they are on a team, they will stay with their team and their leader for the majority of the entire week. There will be full camp, or full group rehearsals and performances.
- We will have hand sanitizer available, but encourage you to bring your own.
- Prior to camp, we ask you to wash or sanitize your hands.

- If you want your child to wear a mask or gloves, they need to bring them.
- Our staff will be cleaning and disinfecting common areas throughout the day.
- We will have regular handwashing/disinfecting breaks after each session or activity as needed.
- We need to be flexible if changes need to be made on the fly.
- Snacks, water, and drinks will be available for purchase, however, campers need to be responsible for their own snack money each day.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending activities at The Studio, LLC and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at The Studio may result from the actions, omissions, or negligence of myself and others, including, but not limited to, The Studio employees, interns, or other members.

I have carefully read and voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at The Studio or participation in The Studio programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless The Studio, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of The Studio, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Studio program.
